In terms of U.Reg.21 (UG) under Examination regulations of Under Graduate Examinations and in reference to B.A./B.Sc./B./Com. Honours/General examinations for Part II of 3- tier for the year 2017, it is notified for all concerned that the candidates who intend to re-examine of answer scripts in theory papers may apply in a prescribed form with requisite fees through the Principal / TIC for the period from **14.02.2018 to 28.02.2018**. Fees for re-examination of answer scripts @. Rs. 150.00 per paper once paid, will not be refunded under any circumstances. The Re-Examination of answer scripts in theory papers only, (excluding any practical paper or internal assessment or project work/field work) may be done in accordance with the following procedure:

- In terms of clause U.Reg.21(UG) 2, a candidate of **PART-II Honours** course is entitled to apply for review subject to the provision of U.Reg.21(UG) para.1, above in a maximum number of two theoretical papers, irrespective of marks (two Honours Papers/one Honours Paper & one General Paper/two General Papers) provided he/she has secured at least 30% marks in aggregate of the remaining theoretical papers (Honours and General Papers taken together, as the case may be not asked for Review) excluding the marks secured in Language Papers (in PART I Examination).
- In terms of clause U.Reg.21(UG) 3, A candidate of **General Course of PART-II** Examination may apply for review subject to the provision of U.Reg.21 (UG) para.(1) in one or two General Elective Paper(s) irrespective of marks provided he/she has secured at least 30% marks in aggregate in the remaining General Elective Papers (excluding Compulsory Language Papers & Environmental Studies, as the case may be) not asked for review in each PART of his/her Examination.

The office of the colleges are requested to submit the aforesaid application maintaining the serial of category-wise and Roll No -wise with a following statement to the Office of the Controller of Examinations positively on **02.03.2018**.
